1. UNIVERSITY PUBLICATION REQUIREMENT

(a) SEMESTER I, 2017/2018 TO SEMESTER II, 2022/2023 INTAKES

• 1 full length or systematic review article (Web of Science: Science Citation Index Expanded/Social Sciences Citation Index/Arts & Humanities Citation Index)

OR

 1 authored book published by an international publisher or a publisher listed in Web of Science master list/Malaysian Scholarly Publishing Council or Majlis Penerbitan Ilmiah Malaysia (MAPIM)/recognised by Universiti Malaya or Faculty)

OR

• 2 book chapters (publisher listed in Web of Science master list/Malaysian Scholarly Publishing Council or Majlis Penerbitan Ilmiah Malaysia (MAPIM)/ recognised by Universiti Malaya or Faculty)

OR

- 2 full length articles or systematic reviews listed in any of the following:
 - Emerging Sources Citation Index
 - Scopus
 - Malaysian Citation Index (MyCite)
 - Faculty journal list (Journal B)

OR

• 1 book chapter AND 1 article (indexing/publisher status as above)

(b) STARTING SEMESTER I, 2023/2024 INTAKE (Senate approval 24 Aug 2023)

• 1 WoS/ Scopus Q1 or Q2

OR

 2 Scopus Q3 or Q4/ Emerging Sources Citation Index (ESCI)/ ERA Journal List (Australian Research Council)

OR

- 1 Scopus Q3 or Q4 + 2 UM Journal (up to 31 Disember 2025 only)
 OR
- 1 book (International publisher/WoS Master Book List/ Penerbit Universiti Malaya (UMPress)/ Dewan Bahasa dan Pustaka (DBP)/ Majlis Penerbitan Ilmiah (MAPIM)/ publisher approved by faculty (including university publisher).
 OR
- 2 book chapters (WoS Master Book List/ Penerbit Universiti Malaya (UMPress)/ Dewan Bahasa dan Pustaka (DBP)/ Majlis Penerbitan Ilmiah (MAPIM)/ publisher approved by faculty (including university publisher).

2. IMPORTANT NOTES

- Topic of publication must be related to the thesis.
- The candidate must carry Universiti Malaya affiliation.
- The supervisor must be the corresponding author.
- If there is an external co-supervisor, the Universiti Malaya supervisor must be the corresponding author.
- Authorship guideline: See UM <u>Policy-of-Authorship.pdf</u> and terms/author responsibilities as stipulated by a journal/publisher.
- Other than the candidate and supervisor(s), if an additional author is added to a publication, consent must be obtained from the candidate and supervisor(s). The additional author must have genuine scholarship and authorship contributions.
- If two or more candidates co-author an article, only one candidate is allowed to use the article to fulfil his/her graduation requirement.
- Candidate may publish in any language.
- Proof of acceptance can be used for graduation purposes.
- Candidate must consult the supervisor(s) **before** beginning work on any publication and must not submit the work without the supervisor's knowledge.
- All authors must adhere to research/publication ethics and integrity.
- Ethical infractions may lead to disqualification of publications for graduation requirements and/or disciplinary action.

3. FACULTY JOURNAL LIST

- (a) The faculty journal list refers to a list of legitimate peer-reviewed journals recognised by the faculty including those published by recognised universities or endorsed by the Universiti Malaya Library. It is possible that they may not be indexed in the Web of Science or Scopus.

(e) FAQs

- What if a journal is found to be blacklisted after submission or at the point of acceptance?
 - Withdraw the article and re-submit it elsewhere.
- What if a journal is blacklisted at a later point but was legitimate at the point of acceptance?
 - The status of the journal at the point of acceptance is considered.
